The Vendor does not accept any person interested in purchasing having queued up at the ICC Venue before the time of sale. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any person interested in purchasing by any method (including balloting).</li><li>2. The Vendor reserves the right to close the ICC Venue at any time if all the specified residential properties have been sold out.</li><li>3. If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 9:00 a.m. and 9:00 p.m. on any date of sale, for the safety of the prospective purchasers and the maintenance of order at the ICC Venue, the Vendor reserves its absolute right to the ICC Venue.
