<ol style="list-style-type: none"> <li>Any person interesting in purchasing any of the specified residential properties shall personally attend the ICC Venue at 62/F, International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong between 11:00 a.m. and 11:15 a.m. on the first date of sale. At or after 11:15 a.m. on the first date of sale, the order of priorities of each of such persons in selecting and purchasing the specified residential properties shall be determined by (a) firstly, the descending order of number of specified residential properties such persons wish to purchase as indicated to the Vendor on spot, but in any event such number shall not exceed six; and (b) secondly, by balloting if there are more than one person indicating the same number of specified residential properties that he/she/it wishes to purchase, and each such person shall have one lot for the purpose of balloting. If a person does not select and purchase the same number of specified residential property(ies) as indicated to the Vendor, his/her/its order of priority shall lapse immediately and shall not be allowed to select and purchase any specified residential property.</li> <li>After completing the sales procedure as mentioned in paragraph 1 above, all remaining specified residential properties (if any) will be offered to be sold to any person on a first come first served basis.</li> <li>The Vendor reserves the right to close the ICC Venue at any time if all the specified residential properties have been sold out.</li> <li>If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 9:00 a.m. and 9:00 p.m. on any date of sale, for the safety of the prospective purchasers and the maintenance of order at the ICC Venue, the Vendor reserves its absolute right to the ICC Venue.
