At or after 11:15 p.m. on the first date of sale, the order of priorities of each of such persons in selecting and purchasing the specified residential properties shall be determined by (a) firstly, the descending order of number of specified residential properties such persons wish to purchase as indicated to the Vendor on spot, but in any event such number shall not exceed eight; and (b) secondly, by balloting if there are more than one person indicating the same number of specified residential properties that he/she/it wishes to purchase, and each such person shall have one lot for the purpose of balloting.
